Subject: Closure of the programme "Entrepreneurship and Innovations" (CCI No 2007LV161PO001) – Interruption of the period for retention of documents with regard to the operations affected by pending cases

Dear Mr Eberhards

The Commission services received the closure documents referred to in Article 89(1) of Regulation (EC) No 1083/2006 concerning the assistance in reference on the following dates: the final implementation report on 30 March 2017, the closure declaration on 30 March 2017 and the certified statement of expenditure including an application for payment of the final balance on 30 March 2017.

By letter Ares(2018)3960373 of 26 July 2018, the Commission services sent a preclosure proposal to the authorities of the Republic of Latvia suggesting to deduct the amount affected by pending cases as it had no impact on the amount of assistance from the ERDF to be paid. Following this pre-closure proposal, the Republic of Latvia has received payment of the final balance on 3 August 2018.

The above-mentioned pre-closure proposal has not been accepted by the authorities of the Republic of Latvia Ares(2018)4701734 of 13 September 2018.

The starting date of the three-year period during which the supporting documents in relation to the above-mentioned assistance must be kept available in accordance with Article 90 of Regulation (EC) No 1083/2006 is to be fixed at 3 August 2018, which corresponds to the payment of the final balance.

However, pursuant to Article 90(1) of Regulation (EC) No 1083/2006, we must inform you that we have decided to interrupt the three-year period with regard to the operations affected by pending recoveries, irrecoverable amounts and on-going national investigations as from the date of receipt of this letter.

For this reason, the closure documents have not yet been accepted by the Commission and the closure of the assistance has not yet been carried out.

As soon as the above-mentioned pending cases are resolved, the Commission will proceed with the closure of the corresponding assistance. The interruption of the three-year period with regard to the operations affected by the above-mentioned pending cases will be considered lifted as from the date of receipt of the closure proposal from the Commission.
